Orange recently acquired Airtel in Sierra Leone; the company is undergoing a shift in management accordingly that is likely to affect operations and investment. Africell Money launched at the end of 2016 with an uptake of 13,000 active users and 200 agents to service them.

Who is Azuri & how does it work in Sierra Leone?

In 2013, Azuri launched operations in Sierra Leone in partnership with a local company, Teleficient Communications Ltd. to adopt and replicate the supplier's product offering and pay-as-you-go (PAYG) business model to service last mile consumers marking the entry of PAYG financing in Sierra Leone.

Which mobile payment system is most popular in Sierra Leone?

Airtel money is currently the most prominent mobile money payment system, with the widest outreach in Sierra Leone. With 3,584 agents in office and mobile to service an active customer base of 372,419 customers making over 7,500 transactions daily and up to 1.8 million transactions monthly.
