In October 2022, Cameco along with Brookfield Renewable Partners announced the acquisition of Westinghouse Electric Company in a US\$7.9 billion deal including debt. Cameco will own a 49% interest in the company as part of the deal. The acquisition was completed in November 2023.

#### When did Cameco IPO?

The initial public offering (IPO) for 20% of the company was conducted in July,1991. Government ownership of the company decreased over the next eleven years,with full privatization occurring in February,2002. In 1996,Cameco acquired Power Resources Inc.,the largest uranium producer in the United States.

#### When did Cameco buy Uranerz?

In 1996, Cameco acquired Power Resources Inc., the largest uranium producer in the United States. This was followed in 1998by the acquisition of Canadian-based Uranerz Exploration and Mining Limited and Uranerz U.S.A., Inc.
