

How much energy will Centrica store at Brigg?

The battery installed at Brigg represents the largest investment in storage capacity Centrica has made to date. It will have the capacity to store 100MWh of electric energy, equivalent to a full day's energy consumption for around 15 per cent of the homes in North Lincolnshire.
