### What makes Neoen unique?

Delivering clean energy 24/7 - our first baseload contract of 70 MW with BHP combines wind from Goyder South, storage from Blyth Battery and our energy management smarts. ### Will Neoen finance the energy transition?

The FSP, which strategy is to remain committed to financing the energy transition, has been at Neoen's side since the IPO in 2018, and along the capital raises to fund the growth of its installed capacity thereafter.

#### What is Neoen's main business line?

The Neoen name would live on under Brookfield, which is also taking on the target's staff. "So it's a perfect alignment of plans - everyone seems to be quite happy with the deal."

#### How many gigawatts does Neoen have?

Including projects in development and expected to be delivered over six to 10 years, Neoen's domestic pipeline of projects over the next decade is nearly 10 gigawatts. Neoen owns the Victorian Big Battery outside Geelong in Victoria.

A major development ongoing with Neoen is its acquisition by global investment group Brookfield. Earlier this year (30 May), Canada's Brookfield Asset Management clean energy arm Brookfield Renewable and Singapore-headquartered investment trust Temasek negotiated with Neoen's shareholders to secure a 53.32% stake in the company.
