## What is Mauritania's energy mix?

In 2019, Mauritania's energy mix was dominated by oil products (65%) and biofuels and waste (32%). Mauritania & #160; is a major oil supplier, exporting more than 85% of its oil production in 2013. It also has strong onshore wind power potential. However only 30% of the population has access to electricity.
