How much wind and solar power will be installed in 2022?

The National Development and Reform Commission and the National Energy Administration, in their 2022 Implementation Plan on Promoting New Energy's High-Quality Development, set a target to reach a combined installed capacity of over 1.2 TW for wind and solar power by 2030.

What is the policy related to solar energy development?

The only policy related to solar energy development is the supply-side R&D policyto promote and follow the development of solar technology. For the demand-side, Solar PV was planned by the government as the solution for non-electricity remote areas.

What is the State Council's new energy development plan?

The State Council released a circular on the implementation plan to promote the high-quality development of new energy in the new era, drawn up by the National Development and Reform Commission and the National Energy Administration, on May 30.

What is the purpose of the National Development & Reform Commission?

To encourage the construction of offshore wind power bases and promote the deployment of offshore wind power in deep-water and offshore areas. (National Development and Reform Commission, 2022b) Steadily promote structural transformation and accelerate the transformation of green and low-carbon energy.

Why did the NDRC change the feed-in tariff for solar power?

In 2016, the NDRC issued a notice that modified the feed-in tariff benchmarks for onshore wind power and photovoltaic power generation. As a result, the feed-in tariff for solar PV power transitioned from being subsidy-driven to prioritizing grid parity.

Why is China interested in solar photovoltaic technology?

Initially, China prioritized wind power for renewable energy development due to its well-established technology. However, the Key Points of New Energy and Renewable Energy Industry Development Planning 2000-2015, published in 2000, marked the beginning of China's interest in solar photovoltaic technology.
