Ground has been broken on the St Kitts microgrid while negotiations and developments continue with the Nevis Geothermal project. The St Kitts facility to be comprised of 37.5MW solar PV and a 14.8MW/45.7MWh lithium-ion battery energy storage system is a major development for the nation and a landmark for the region.

The solar PV will supply St. Kitts with 30 - 35% of the annual electricity demand utilising sustainable, solar energy with zero emissions. The solar and storage system will replace over 4,000,000 gallons of diesel per year.

Construction of the solar + storage microgrid facility on St Kitts has commenced and the Nevis Geothermal project advances. The St Kitts facility to be comprised of 37.5MW solar PV and a 14.8MW/45.7MWh lithium-ion battery energy storage system is a major development for the nation and a landmark for the region.

Construction has begun on a solar-plus-storage project on the Caribbean island of St. Kitts & Nevis, backed by Leclanch&#233;, Solrid and MPC Energy Solutions. The launch of the SOLEC power plant is nearly 18 months later than expected with the start of construction first announced back in December 2020, covered by Energy-Storage.news.
