### Who is Tonga Power Limited?

Tonga Power Limited is Tonga's sole electricity provider. We generate, distribute and sell electricity to more than 25,000 plus customers in the Kingdom of Tonga, including the outer islands of 'Eua, Ha'apai & Vava'u.

### Can a power concession be terminated in Tonga?

Pursuant to SAection 20 of that Act, TOnga Power Limited (TPL) has been granted a concession to generate and supply power throughout Tonga. While the Concession is for an open period, it can be terminated by the Government upon giving not less than three and nort more than six months notice prior to the Reset Date.

### What is the Tonga wind power project?
