What is the energy policy of Trinidad and Tobago?

The Government of Trinidad and Tobago is currently developing a national energy policy green paperthat recognises renewable energy's (RE) combined with energy efficiency (EE) and utilisation of compressed natural gas in the transportation sector, inter-alia, as important strategies for the promotion of sustainable development of the nation.

How does Trinidad and Tobago use natural gas?

Trinidad and Tobago shifted from using oil to using natural gas to run its industries. Currently,natural gas is the main energy source in the country. The natural gas is used in various sectors in the country such as electricity production and petrochemical factories.

In Trinidad and Tobago (T&T)\,electricity is primarily produced by burning natural gas. The heat energy released is used to produce steam. This steam is then used to turn a steam turbine which is connected to an electrical generator to produce electricity.

Trinidad and Tobago's population is growing at a rate of around 4% annually. It has been projected that we will need another power plantin the early 2020s based on this growth rate.

Who owns power generation in Trinidad & Tobago?

Power Generation Company of Trinidad and Tobago (POWERGEN) Ownership: In 1994,T&TECdivested its generation assets to POWERGEN,a company whose ownership structure at the time was led by T&TEC with a 51 percent shareholding,followed by Southern Electric International with 39 percent and Amoco with 10 percent.

for nearly 80% of Trinidad and Tobago"s (T& T) export revenues and thus, the energy sector remains a cornerstone contributing significantly to government revenue, export earnings and GDP. In the 2025 National Budget presentation, The Minister commented that the energy sector will be a major contributor to our economic survival for years to come.
