In 1974, Canadian New Democratic Party MP Max Saltsman proposed in his private member's bill C-249, & quot; An Act Respecting a Proposed Association Between Canada and the Caribbean Turks and Caicos Islands & quot; that Canada form an association with the Turks and Caicos Islands; however, it was never submitted to a vote.

Where is International School of the Turks and Caicos Islands?

International School of the Turks and Caicos Islands, a private school which serves preschool through grade six, is in Leeward, Providenciales. In 2014 it had 106 students. It was known as The Ashcroft School until 2014.
